The Network offers members access to a free data collection tool which allows collection of standardised data across Europe. The Network already has 52 members in 21 European countries and wish to expand in the EECA region. The session is suitable for organisations offering CBVCT services and public health bodies interested in incorporating CBVCT data into their surveillance systems.

The People Living with Stigma Index 2.0 - Lessons learnt from implementations in Baltics to inform responses to HIV related stigma in EECA

The People Living with HIV Stigma index has been implemented in more than 70 countries. It is a community based participatory research tool and process to gather data on HIV related stigma from a PLHIV perspective. In 2017 an updated and revised Stigma Index was created to reflect important changes such as recommendation for early initiation of treatment, increased evidence about how different populations are affected by stigma, to give greater attention to the experiences of people living with HIV. Version 2.0 also assesses stigma and discrimination experienced by people living with HIV for reasons other than their HIV status - due to their sexual orientation or gender identity or being involved in sex work or drug use. Two of the first full implementations of the revised tool have been in Lithuania and Latvia - in late 2017 and early 2018.

Russia as a provider of HIV infection and discriminatory policies in the region: Russia's influence on the HIV epidemic in the region and politics

Russia, being a huge country with a long border, always prefers to have allies on the border, not opponents. Allies are those who share similar views, including politics. You can change your policy in accordance with world trends, to change the world trends is difficult, but it is possible to influence the policy change of neighboring countries. Russia has demonstrated this over the past few years. But in the Russian Federation this is not recognized, just as at the state level the HIV epidemic is not recognized - the government does not only fight its spread, but also hinders external assistance. Foreign funds are leaving

the country. What is the threat to the world, especially to neighboring countries? Support is being deprived of activist initiatives, service and human rights organizations within the country, the last deterrent barrier to discriminatory laws and the spread of the epidemic. The Iron Curtain will not stop emigration from the country, the most vulnerable ones will be forced to flee, as 2/3 of HIV-infected people in Russia do not receive treatment, they are forced to go to where they will be treated.

Despite the fact that in EECA countries harm reduction programs have been financed for more than 20 years, they do not

correspond to the declared philosophy, and are more reminiscent of HIV prevention programs that are not effective due to repressions. This leads to an increase in the epidemic not only of HIV, but also of tuberculosis, hepatitis and other diseases. Every year, the number of people with severe forms of dependence from prohibited substances increases, despite all the efforts of states in the war on drugs. Our life is constantly under threat of criminal prosecution, disproportionate punishment and illegal detention due to addiction. We can not get adequate help. Today the spread of HIV has ceased to be dangerous in the eyes of politicians and donors, they are not ready to interfere in the internal affairs of states, change the situation with human rights just for the sake of reducing the epidemic. But it is the violation of the rights of people with drug addiction, violation of the right to treatment, deprivation of liberty for use - is nothing less than a persecution because of disease. The refusal to provide medical services only because of belonging to a group of people who use drugs, leads to an increase in the epidemic. Enough to chase us! Chase the virus!

Innovative partnership and healthcare reform: eHealth system as an innovative platform for cooperation between NGOs, government and business in Ukraine

In late 2016 the Ministry of Health of Ukraine (MOH) came up with two fundamental reforms in primary health care financing: Capitation (per capita payments for primary health care specialists) and Reimbursement (governmental drug reimbursement program). In order to ensure reforms effectiveness All-Ukrainian Network of PLWH has initiated the development of eHealth systems. An innovative partnership approach including NGO's, Government and businesses has been chosen and embodied in Memorandum signed by more than 180 parties. We have created an effective system of checks and balances giving 'green light' to reforms which seemed to be impossible.
